WHEREAS the Petitioner above named through their Advocate Sri R.S. Associates presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction particularly one in the nature of a WRIT OF MANDAMUS directing the Respondent No. 2, 3 and 4 to implement Industries (Development and Regulation) Amendment Act, 2016 as amended by the Ministry of Law and Justice, Union of India vide its Notification No.27 of 2016 dated 14-05-2016 which brought the industries involved in the manufacture of ethanol for the purpose of blending with petrol under the exclusive control and authority of the Union Government, and removed the control over the

same from the purview of the State Government, in the State of Telangana, and consequently, not to interfere with the commencement and operations of the dedicated ethanol plant of the Petitioner No.1;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri R.S. ASSOCIATES Advocate for the Petitioner and Sri GADI PRAVEEN KUMAR for respondent No.1 & GP for General Administration for respondent No.2 & GP for Exhibition Excise for respondent No.3 & GP for Industries and Commerce for respondent No.4 & SC for IOCC for respondent No.6, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
