Subject: Request for Feedstock Conversion from SFG to Other Feedstocks (Maize & DFG) on a Case-to-Case Basis.

Respected Sir,

We, on behalf of the Grain Ethanol Manufacturers Association (GEMA), would like to bring to your kind attention a critical issue affecting multiple ethanol plants due to the delay in the issuance of indents for Quarter 2 under Tender Cycle 3, which exclusively mandated Surplus FCI Rice (SFG) as the feedstock. Earlier all tenders were issued with Maize & DFG as feedstock & it is the first time that a tender exclusively for surplus FCI rice (SFG) has been published.

Due to this delay, some ethanol manufacturers, in order to maintain operational continuity and meet their financial obligations, had to produce ethanol using alternative feedstocks such as Maize and Damaged Food Grains (DFG). Consequently, several member plants now have significant opening stock of ethanol produced from Maize/DFG, as well as an inventory of these grains.

With the issuance of Tender Cycle 3 for Q2 exclusively for SFG-based ethanol, these plants are now facing operational and financial distress, as their working capital cycles are adversely impacted due to the unsold ethanol stock from Maize/DFG and the raw material inventory.

In the recent virtual with the three OMCs, it was discussed and assured that OMCs may consider allowing feedstock conversion on a case-to-case basis, provided the affected plants submit a Chartered Accountant (CA) certificate verifying that the stocks were available before the issuance of the tender.

Additionally, as per the requirement for new DEPs, certain members had undertaken ethanol production to comply with the Third-Party Inspection Agency (TPIA) certification, ensuring continuous production up to the LTOA quantity. This has further contributed to the accumulation of ethanol stock from Maize/DFG.

Request for Consideration:

In light of the above, we earnestly request OMCs to analyze and approve feedstock conversion from SFG-based ethanol to ethanol produced from Maize/DFG on a case-to-case basis for affected plants. We are prepared to provide necessary supporting documentation, including CA certification, to substantiate the claim.

Your kind consideration and approval of this request will significantly help ethanol manufacturers sustain their operations and ensure uninterrupted ethanol supply under the ongoing procurement cycle.

We look forward to your positive response at the earliest.

We refer to the tender for C-3 (Tender ID 18791 and TENDER REFERENCE NO. – 1000423858 (C-3)), which was floated on 29-01-2025 for the supply of 124 crore litres of denatured anhydrous ethanol during Q2 & Q3 of ESY 2024-25, to be produced from C-Heavy molasses and surplus rice sourced from FCI.

We had successfully participated in the tender and were allotted quantities of ethanol to be supplied from surplus rice sourced from FCI. However, since we were not allocated the required FCI rice, we were unable to commence supply, and a substantial period of Q2 (Feb, March, and April 2025) has already passed.

Before the tender was issued, we already had stock of 5803.699 KL of ethanol produced from maize (as of 28-01-2025), along with a stock of maize amounting to 17071.14 MTs, as verified by the Chartered Accountant certificate enclosed herewith for your reference. As we continue to hold a substantial stock of ethanol from maize feedstock as well as raw maize, this has severely impacted our working capital and overall financial liquidity.

In light of the above, we humbly request your approval to convert at least 5803.699 KL of ethanol produced from maize against the allotted quantity of ethanol from surplus rice, ensuring timely fulfillment of our supply obligations. Given the current situation, we believe that allowing this conversion would not only help ease our financial strain but also support the overall health of this DEP .





This is a humble request to look into the below matter on an urgent basis for sustainability of the grain based ethanol distilleries.

Our company K G Spirits LLP along with other plants had participated in the C1 and C2 tender for allotment of supply of ethanol for all the four quarters of the Ethanol year. We had successfully allotted the supplies with the feedstock as DFG and Maize. Both these tenders did not include FCI rice as feedstock.

In the month of Feb 2025, C3 tender came out especially for FCI rice feedstock to be participated by plants. Only plants which had not participated in C1 and C2 or plants which had additional production could participate in the C3 tender. OMC for other plants like us were offered to convert the feedstock to FCI rice for Q3 and Q4.

Now we are standing after a month and C3 allotment has been granted. The plants including us which had given requests for feed conversion haven't got any reply yet. Q3 is going to start in 45 days and we are desperately waiting for the conversation to get executed by the OMC's.

Sir, even with earlier prices of DFG on the market the plants were unviable and losing capital and now the government has allowed export of DFG in March 2025 and this has brutally resulted in increase the prices in the market. The plants will not be able to survive with market DFG as feedstock and we urgently need your support for procurement of FCI rice to overcome this situation.

Sir we hope OMC will take up this matter urgently and provide relief to us.
